1. As between the Exhibitor and the Producer, the Producer shall have the final authority to determine the location of an Exhibitor's display within the show and the Exhibitor's compliance with the aforesaid rules, regulations and policies.
2. Once the Exhibitor's display and/or vehicle are set up in the show, they shall not be removed or concealed by the Exhibitor prior to the end of the show without the permission of the Producer.
3. Nothing herein contained shall require the Producer to produce the show. The Producer shall, consequently, be entitled to cancel or otherwise fail to produce the show without liability to the Exhibitor or Vendor.
4. Neither the Producer, the Sponsor, nor any officer, director, or shareholder thereof, or the owner of the building at which the show is produced, shall be responsible or liable for any loss of or damage to all or any part of the Exhibitor's display and/or vehicle, and the Exhibitor shall and does hereby waive any and all rights he may have against them or any of them for any such loss or damage.
5. All non-automotive related commercial exhibits will have to be approved by the Texas Show Car Association.
6. This is a family event. Vendors and exhibitors are expected to act accordingly and display merchandise suited for family viewing.
